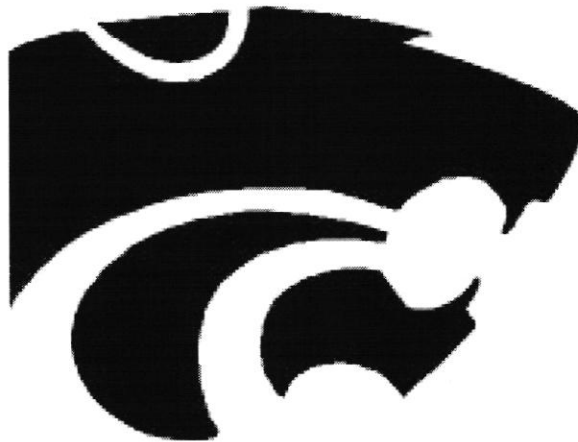

FOR CANNED AND DRY; FROZEN: MEAT AND MEAT PRODUCTS, VEGETABLES; AND REFRIGERATED

SECTION I: INSTRUCTIONS

The general rules and conditions that follow apply to all purchases and become a part of each formal invitation to bid, purchase order or other award issued by the Central Community School System, Child Nutrition Program, unless otherwise specified.
